FLAT TAX NON-EU COUNTRIES

Non-EU flat submitting residents may obtain а tax by а request to gestione.iscrizione@fondazionemilano.eu. This will mean that they do not need to submit any further documentation on the income and assets of the household residing abroad. Together with the request, the student must present a certification from the Italian Representation in the country of origin certifying that the student does not belong to a family known to have a high income and high social standing (Article 13[5] of the Decree of the President of the Council of Ministers 09/04/2001).

The relevant office shall assess which country list the student belongs to and which course they belong to according to the lists below, and will then apply the lowest, middle or highest fee indicated for the course on which they are enrolled.

If the student does not apply, they must submit an EQUALISED ISEE (Equivalent Economic Situation Indicator) for foreign nationals, otherwise they will fall under the highest fee.

The relevant fees and country lists are published below.

<u>Switzerland, San Marino and Vatican City</u> are non-EU countries but are not included in these lists: citizens of these countries, who have income and assets abroad, must submit an EQUALISED ISEE.
